

# Providence Housing Authority

The Providence Housing Authority (PHA) will be amending its 2025 Annual Plan submission to the U. S.

Department of Housing and Urban Development (HUD). This amended Annual Plan will reflect the attached revisions to the PHA's Admissions and Continued Occupancy Policy and the PHA's Administrative Plan for the Housing Choice Voucher (HCV) Program. A public comment period begins on 10/13/25 and ends on 11/27/25.



## **Overview of Changes for the Administrative Plan (Admin Plan)**

### **Chapter 4: Applications, Waiting List and Tenant Selection**

- **(Discretionary Policy Change)**
  - Added an Emergency Housing Voucher (EHV) preference to the HCV waitlist for families displaced as a result of the termination of the EHV program.

### **Chapter 7: Verification**

- **(Discretionary Policy Change)**
  - Added language explaining how the PHA will verify the EHV preference.

#### **Chapter 7.B.**

- **(Discretionary Policy Change)**
  - Added language explaining how the PHA will verify the EHV preference.

### **Chapter 11: Reexaminations:**

#### **Chapter 11.B.**

- **(Discretionary Policy Change)**
  - Added language establishing a threshold of 10% or less for conducting an interim recertification due to a decrease in income.

### **Chapter 17: Project-Based Vouchers:**

- **(Discretionary Policy Change)**
  - Added an Emergency Housing Voucher (EHV) preference to the PBV waitlist for families displaced as a result of the termination of the EHV program.

### **Chapter 19: Special Purpose Vouchers:**

- **(Discretionary Policy Change)**
  - Added an Emergency Housing Voucher (EHV) preference to the Mainstream waitlist for families displaced as a result of the termination of the EHV program.
