The meeting will also consist of jobsite walk-through of the thirty-seven (37) boiler rooms, basements, and crawl spaces in order to provide insight into the existing conditions of the hydronic piping system belonging to the Chad Brown & Admiral Terrace developments. During the walkthrough, bidders are encouraged to take / note accurate measurements (sizes, dimensions, weights, capacity, volume, etc.) and develop an understanding of the existing site conditions related to the necessary labor, materials, equipment, storage, transportation, and accessibility in order to prepare an accurate bid. Change Orders will be scrutinized and will not be considered for existing conditions that are known or that the Bidder should have known, including but not limited to conditions present at the Pre-Bid Meeting.
